## TERMS AND CONDITIONS OF THE HAWTHORN WEIGHTLIFTING CLUB

Welcome to Hawthorn Weightlifting Club, a section of the Hawthorn Citizens' Youth Club Incorporated. Before signing your Hawthorn Weightlifting Club Membership Agreement please take the time to read the following explanations regarding the cost of membership and other important information as well as all relevant information on the invoice and club membership agreement forms.

### Requirements as a Member

As a member the club requires you to assist at four (4) competitions per year, two (2) of which will comprise of major events (state titles, national level event or international event), with the remaining two (2) consisting of VWA calendar events held at the Eleiko Victorian Weightlifting Stadium. To assist in the scheduling of volunteer effort, a roster will be released at the start of 2017 with names and competitions in which you will be assisting. These will be emailed and posted on the boards at the Stadium. You may negotiate change of dates if the assigned dates do not suit you. You will be required to assist in both the setups and clean-ups for the days you are rostered on. Setup is held the day prior to each event held at the Eleiko Victorian Weightlifting Stadium, and generally occur after Friday night training, so it is a simple matter to train then assist in setting up.

### Payment Methods

Direct debt systems along with the current cash and EFT (electronic funds transfer) methods are to be used in 2017. Members may choose to be charged weekly, monthly or annually. See pricing structure below:

Note: Members entitled to a Pro Rata rate in 2016 will have their start date delayed to a date which appropriately gives commensurate compensation to the member. As such, the above date is the adjusted date that billing will begin on *Membership for HWC will be for a minimum of 12 months from the date of sign up to the club. Members who wish to terminate their membership prior to this time will only be able to do so under the following circumstances a) Illness or injury precludes the individual from performing any physical activity at HWC, including rehabilitation, and a Medical Certificate must be provided, b) The individual moves the primary residence to a residence no less than 50km from the operating area of HWC, with evidence provided c) The individual pays in full 90% of their sum total of their remaining obligations to the club, d) By approval of the HWC board, subject to a written application to grant termination of membership. Following the 12 month period, membership will be ongoing, unless the member provides the club (via a Senior Club Member) with a written application to terminate membership, no less than 2 weeks prior to the date on which the membership will cease.*

HWC is entitled to apply a 5% membership fee increase and vary the periodic withdrawal accordingly. If an increase greater than 5% is applied in any 12 month period you will be notified in writing and be entitled to discontinue your membership without penalty.

**Suspension:** Members will be entitled to suspend their membership for a period of 2 weeks per year. During this time no charge will occur.

**Waiver and release:** During all such times that you are on HWC premises your property and your person shall be at our own risk and you will not hold HWC or its coaches liable for any personal injury or loss of property whether caused by the negligence of HWC, its servants or agents.

You hereby indemnify and shall keep indemnified HWC from any liability for all actions, suits, claims, accounts and demand for any personal injury or loss of property arising or in any way connected with your use of our facilities (in such claims) including any such claims caused or contributed to by the negligence of HWC, its servants or agents.

**Death or Disability of Buyer:** If you die or you become disabled in such a way that you are unable to use the facilities you or your legal representative may rescind this agreement.
